As a participant in an Intermediate Punishment Sanction(s), I understand the following rules, regulations and directions shall apply:

- House Arrest w/Electronic Monitoring/Electronic Monitoring**
- a. I must pay a mandatory \$90.00 EHA fee as prescribed by G.S. 15A-1343, unless the court has exempted me from paying for good cause and upon my motion to the court.
 - b. I agree to reside at _____, _____, telephone contact number _____. I will not leave my residence at any time except as authorized by my Probation/Parole Officer. If I have to leave my residence on an emergency, I will first try to get permission from my Probation/Parole Officer. I understand that I will be required to furnish documentation and verify my emergency departure from my schedule.
 - c. To ensure compliance, I will be monitored using electronic technology which I agree to wear during the entire period of my home incarceration. I agree not to move, disconnect or remove the monitoring device located in my home. The House Arrest restrictions will also be monitored by telephone calls to my residence. I acknowledge receipt of Monitor/Transmitter/Portable Unit # _____ and understand this monitor will be installed in my place of residence and the transmitter on my person and I will carry a portable unit at all times or as directed by my Probation/Parole Officer. I understand that failure to return this monitor/transmitter/portable unit at the end of the EHA/EM period or failure to reimburse for any damages to the monitor/transmitter/portable unit may result in criminal proceedings as well as violation procedures against me.
 - d. I understand that it is my responsibility to obtain and maintain a basic landline telephone service in the event that there are technical and geographical limitations to result in poor cellular coverage. I understand that no optional telephone features will be allowed on the line and I will not install the internet or answering machines to the landline telephone service during my monitoring period.
 - e. I understand that the purpose of this monitoring equipment is to alert my Probation/Parole Officer if I violate the restrictions established. The loss of a receiving signal, absence from my home in violation of my restrictions, or any physical evidence indicating that the monitoring devices have been tampered with or removed shall constitute a violation. I understand that an officer other than my assigned officer may respond to such violations or problems at any time and I agree to cooperate fully with any such officer.

Intensive Supervision

- a. Submit at reasonable times to warrantless searches by a Probation Officer of the defendant, and of the defendant's vehicle and the premises while the defendant is present, for the following purposes which are reasonably related to the defendant's supervision.
- Stolen Goods Controlled Substance Child Pornography
- Contraband Other _____
- b. Not use, possess or control any illegal drug or controlled substance unless it has been prescribed for the defendant by a licensed physician and is in the original container with the prescription number affixed on it; not knowingly associate with any known or previously convicted users, possessors or sellers of any illegal drugs or controlled substances; and not knowingly be present at or frequent any place where illegal drugs or controlled substances are sold, kept or used.
- c. Supply a breath, urine and/or blood specimen for analysis of the possible presence of a prohibited drug or alcohol, when instructed by the Probation Officer.
- d. Complete not less than _____ hours or more than _____ hours of community or reparation as determined by the Probation Officer, and under the direction of the Community Service Coordinator and pay the fee prescribed by G. S. 143B-475.1(b) within _____ days of this Judgment.
- e. Participate in any evaluation, counseling, treatment or education program as directed by the Probation Officer, faithfully keep all scheduled appointments, and abide by all rules, regulations and direction of each program.
- f. Not be away from the defendant's place of residence between the hours of _____ and _____ unless authorized in writing by the Probation Officer.
- g. Not leave the defendant's county of residence without prior approval of the Probation Officer.

I have read and/or had explained to me the Intermediate Punishment Offender Rules and Regulations and I agree to abide by all.
